Resident Spotlight: Thomas Woods, Esquire



As a resident of the Claridge House for five years, Thomas Woods' smiling face has been seen throughout the building. He was asked to share a little about his life, career, experiences and what brought him to the Claridge House.

I grew up in Bowie, Maryland. I went to high school in the Riverdale area. When it was time for college, I spent one year at Hampton University before transferring to Howard University. I completed my undergraduate and law degree at Howard University. In regard to Howard University, I loved my experience there. My father was a professor at the University, so I basically grew up on the campus. Howard brings together so many different cultures and personalities, so every day is a new experience.

Furthermore, the campus and neighborhood has changed so much since I attended. DC's Howard University is the same historically black college (HBCU) the first female US Vice President Kamala Harris graduated from in 1986 before pursuing her law degree at the University of California, Hastings College of the Law.

Like the Vice President, Thomas is an attorney who passed the bar. He worked as a prosecutor in Baltimore, Maryland, worked for a law firm here in DC and now working at the Securities and Exchange Commission (SEC). Thomas replied, it's hard to believe that I've been out of school this long, but it's true. Before going to law school, I worked in Congress, first in the House of Representatives, then in the Senate. Both jobs were very fun and I learned a lot. After working on the Hill, I attended law school. I knew going into law school that I wanted a career where I could combine my love of public service and business. Working as a prosecutor was a dream job for me. There, I had one mandate, which was to do justice. Every day my only concern was the citizens of Baltimore City. As a trial attorney, I probably had over 30 trials before a jury before leaving the office. In regard to the private law firm, I spent time there as well. It was an interesting experience. Even though I did not go into court every day, I still met with clients and provided them with legal advice. After spending time at the firm, I was offered the opportunity to work at the Securities and Exchange Commission as

counsel in the Division of Enforcement. I jumped at the chance. I've practiced law for close to 6 years now. I've handled cases that range from a DUI to a Homicide. Even though they range in seriousness, I enjoyed the legal challenge of all of them.

As a young man, Thomas has daily and future goals. My daily goals are to stay on top of the steady stream of emails that I get every day and to exercise. After the Covid-19 pandemic, it cemented the importance of health. So you can usually find me in the Fitness Center at the Claridge House at some point during the day. In regard to the future, I enjoy the work at the SEC. It's really interesting and the securities industry is an exciting place to work in right now. The crypto area is very exciting and I look forward to seeing its evolution. As far as a future job, I would love to be the NBA Commissioner. Though Thomas may not consider himself to be accomplished, he is well on his way.

When asked what he would pass along to those who want to be in the same profession, Thomas encourages them to work hard and be nice to everyone. You never know where someone will end up. More importantly, being nice doesn't cost anything. The legal profession can be very difficult, but having good friends makes it easier. He was asked about some of the things he likes to do in his spare time. When I'm not working, I love to read! I'm always carrying a book and when I commuted to Baltimore, I probably read over 100 books during my time on the Marc train. I also enjoy hanging out with friends in DC. Friendship to me is very important, so I try to check in on my friends all the time. Lastly, I enjoy traveling.

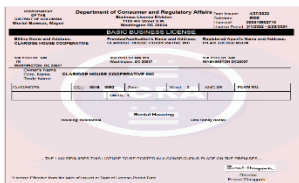

Basic Business License



Those who rent apartments in DC are required by DC law to have a basic business license. Licenses are available through the newly created DC Department of Licensing and Consumer Protection (DLCP). The DC Council passed the Department of Buildings Establishment Act of 2020, creating the DLCP (<https://dlcp.dc.gov/>) and the Department of Buildings (DOB at <https://dob.dc.gov/>) to take over responsibilities under the former Department of Consumer and Regulatory Affairs (DCRA). Service in these departments began at midnight on October 1, 2022.

To obtain a basic business license, go to <https://mybusiness.dc.gov/login>. Landline Telephones

We may clear out our Telephone Room in the North Building Basement in the near future. The room houses equipment for landline telephones in the building. Once the room is cleared out, residents will no longer be able to have landline telephones. Residents will be notified before the room is cleared out. This will not affect cell phones.

Our Coca-Cola vending machine was recently replaced with a Pepsi machine. The Coca-Cola machine was provided through third-party billing and the Coca-Cola company is no longer in the third-party billing business. The new Pepsi machine is next to the snack machine between the Fitness Center and Community Room in the North Building basement. Available 20 oz. beverages include Pepsi, Diet Pepsi, Mountain Dew, Dr. Pepper, Schweppes Ginger Ale and Aquafina water.

Signs and Distribution of Literature

During this political season, please be mindful of the Claridge House Rules and Regulations.

Section 5.1 (e) states that *"No signs are permitted in any common area, either inside (including unit doors) or outside the building. Distribution of commercial and political literature (including restaurant menus, television/phone/cable advertisements, etc.) within the building is prohibited. Written materials may be placed in residents' boxes at the Front Desk."*

In addition, political or religious events are not permitted in our common areas. The approval or disposal of a request for private use of amenities is at the sole discretion of the Board of Directors. The Board reserves the right to issue specific instructions and limitations for any proposed use.

The DC Board of Elections will be mailing ballots for the November 8th General Election to registered DC voters beginning October 3rd. Your completed ballot may be dropped in a Mail Ballot Drop box starting October 14th, taken to an Early Vote Center from October 31-November 6 and on Election Day.
